

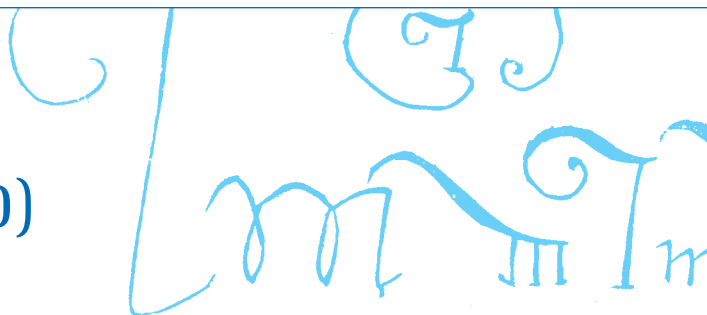
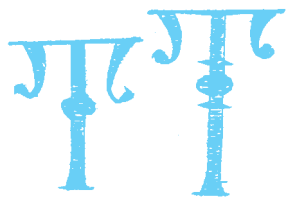

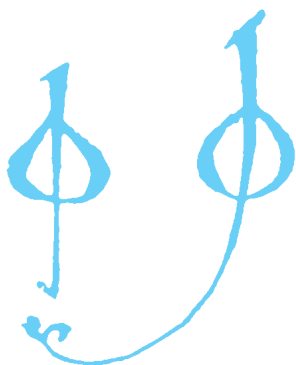

The Slavic alphabet was established in such a way that the letter under the titlo (the special symbol of distinction) could stand for a number. "Title is an honorary name, giving the dignity and pride," Dal' noted. Titlo was used not only over letters to fix the mean-

ing of a number, but over words with skipped letters. This rule of the Old Church Slavonic language stressed the importance of some words. According to rules single titlo was fixed right over the letter. In two or multi-letter case the titlo was fixed over the

second letter from the end of the word. Slash crossed by two short strokes used to stand for a thousand.
